



After finishing your Fundamental level papers, you are now eligible to write a research and analysis report that qualifies you for a BSc in Applied Accounting

At this stage, you will have a good understanding of your likes and dislikes within the industry, and based on that you will choose 2 professional level papers out of 4 selections (AFM, APM, AAA, ATX) to finish off your qualification.
